

Regulatory Reform & Governance Alignment



Challenges

Delays in enacting the revised CA Ordinance and related governance reforms are slowing ICAP's ability to operate independently and respond with agility having an independent effective executive management.

Way Forward

- Support timely enactment and implementation of the revised CA Ordinance to reinforce ICAP's independence, governance, and institutional effectiveness.
- Establish a four-year strategic direction for the Council, ensuring strict monitoring and effective implementation.
- Develop vital amendments to current regulatory regime to introduce the concept of effective executive management.

Intensifying Regulatory Environment



Challenges

Increasing AOB oversight, AML/FATF requirements, and ISQM implementation are creating significant cost and capability pressures, particularly for SMPs. Managing the transition to strengthened QAB/QCR expectations adds further capacity challenges.

Way Forward

Strengthen regulatory readiness and reduce compliance burden for practices, especially for SMPs.

- Launch ISQM, Helpdesk & practical support centers.
- Provide standardized AML/AOB/ISQM templates and toolkits to facilitate implementation.

Digital Transformation and Technology Skill Gaps



Rapid advancements in AI, data analytics, automation, and cybersecurity are outpacing the profession's current digital readiness and technical training.



Way Forward

Accelerate digital skills development to ensure professional relevance and competitiveness.

- Offer free short-courses on AI & data analytics for young members.
- Initiate a Tech-Mentor Program pairing experts with SMPs, young members and students.

ESG & Sustainability
Reporting Preparedness Gaps

Challenges

ESG reporting expectations are expanding faster than the profession's preparedness, leaving capability and guidance gaps in both practice and audit.



Way Forward

Build sustainability reporting and assurance capacity to meet emerging global expectations.

- Strengthen sustainability reporting and assurance capacity, building on ICAP's existing ISSB-aligned initiatives.
- Expand practical ESG adoption through enhanced guidance / targeted assurance workshops with firms / regulators.

Employment & Training Market Constraints

Challenges

Limited job opportunities and reduced training contracts are impacting young members' / students career prospects and threatening the long-term talent pipeline.



Way Forward

Improve youth employability and expand training opportunities to secure future professional sustainability.

- Strategic enhancement of ICAP Career Accelerators including job fairs, mentorships, and internships.
- Introduce trainee intake and training support / monitoring schemes for SMPs and TOoPs.

Global Member Engagement & Mobility

Challenges

Overseas members face constraints in mobility, engagement, and access to ICAP support - affecting international competitiveness and inclusion.



Way Forward

Strengthen international mobility and enhance services and representation for overseas members and students.

- Enable stronger local leadership and committee collaboration for overseas members.
- Improve participation, professional growth opportunities, and timely resolution of member issues.
- · Host virtual engagement forums across key global regions.
