Connect

- Establish an industry-ICAP collaboration forum under NRC to regularly engage with regulators, CFOs and corporate leaders
- Launch "CA Connect Dialogues" quarterly hybrid networking sessions connecting members from practice and industry
- Create a structured feedback system (Online form or quarterly surveys) to gather members' concerns and suggestions for NRC representation at council level.
- Maintain consistent communication via a bi-monthly NRC e-Newsletter highlighting key updates, events and member achievements.

Evolve

- Launch digital CPD hubs offering flexible online courses and recorded sessions ensuring members from remote areas have equal learning access
- Introduce Sector-Based CPD Tracks (Textile, Banking, Energy, Public Sector, Audit etc.) to make learning more relevant to specific industries
- Collaborate with ICAP's technical boards to promote adoption of new standards (IFRS, ISSB, ISA, AI, ESG) through localized workshops
- Conduct Annual Skill Gap Assessments to plan future CPD agendas around real member needs.

Empower

- Introduce a Mentorship & Leadership Development Program pairing senior members with emerging professionals for guidance and networking
- Issue a quarterly "Voice of Members" report consolidating feedback, shared publicly and with ICAP Council (fulfilling Bye-Law 90(3): advise and assist council
- Ensure gender inclusion and equal participation by encouraging more women and early career members in NRC activities.
- Increase transparency by publishing annual performance summaries of NRC activities and fund utilization (Bye law 92).
