- Passed PVEA/Governance & Ethics

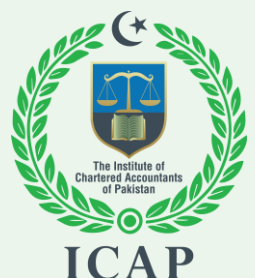
