2. Configure pop-up blocker

(i) If your browser's pop-up blocker is enabled, a blank window may return instead of the Bare Acts page. If you encounter this situation, please close that window and return to the previous tab to disable the pop-up blocker. The pop-up blocker icon would be displayed at the right corner of the address bar as shown in the following picture.



(ii) Click the pop-up blocker icon, select "Always allow pop-ups and redirects from this website" and then click "Done".



(iii) After allowing the pop-ups, click the "Access Now" button again to access the Bare Acts. On the next page, you will find the links to available books. Click the link of the book you want to use.



3. Search function


- (i) It is recommended to use the ICAP Viewer's search function to find the desired text in the book. The search tab can be activated by clicking the magnifying glass icon at the top left corner of the viewer.



- (ii) You can enter your desired search term/text in the 'Find in document' box and use various search filters from the toolbar to get more focused results.



- (iii) For instance, by utilizing 'Fuzzy search' and specifying a range of page numbers, you can locate the word 'salary' even if it has a spelling that is incorrect but close to the correct one on a range of pages.

- (iv) After getting your search results, you can make use of the Page Up and Page Down keys as well by simply clicking anywhere on the page.
- (v) You can go to a specific page number of the book by putting the desired page number in the Page Number box adjacent to the magnifying glass icon.
