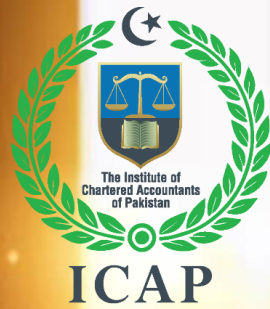

The Income Tax Return: (ITR) is a tax form that is used to file the income details and tax thereon with the Income Tax Department. The tax return is in a predefined format where the income figures are used to calculate the tax liability. Tax returns are required to be filed every year for any person whose income during the year exceeds the threshold limit whether through salary, property rental, dividends, interest, Capital Gains, from any business/ profession or other sources.

It's important to understand and adhere to the specific tax filing requirements and deadlines set by the tax authorities in your country to ensure proper compliance with the tax laws. Consulting with a tax professional or using tax preparation software can assist in accurately completing and filing the Income Tax Return.
