














Declamation Contest:

The NRC of ICAP through CASA-N has organized Corporate Conundrum, a premier study competition, designed case challenge CA Trainee Students with realworld financial complexities, governance dilemmas, and strategic decision-making scenarios. In today's dynamic corporate landscape, financial leaders must balance growth, risk, and ethical responsibility. This competition provides a platform for emerging professionals to demonstrate analytical expertise, ethical judgment, and leadership in high-stakes corporate challenges. With expert evaluation and industry recognition, participants will refine their ability to navigate financial crises, optimize business strategies, and uphold professional integrity.



- Ethical leadership and integrity
- Strategic financial decision-making
- Stakeholder management and governance
- Crisis resolution and adaptability
- Risk identification and mitigation
- Practical application of technical knowledge

Rules | Declamation:

- ❖ A firm/industry can register multiple participants for the competition.
- The competition will feature two language categories: English and Urdu.
- Separate awards (Winners and Runners Up) will be given for each language category.
- ❖ The contest will consist of a **single round**.
- ❖ Participants must deliver their speech while standing at the rostrum. Any unnecessary movement or walking on stage will result in negative marking.
- ❖ Participants may choose between humorous or serious topics.
- ❖ Each category will be judged based on distinct evaluation criteria. Each speaker will have **3 to 4 minutes** to deliver their speech.
- **Exceeding or falling short of the time limit will result in negative marking.**
- ❖ Participants must select and **submit the topic** of their **speech at the time of registration**.
- Once submitted, topic changes will not be allowed to ensure smooth event execution.

Special Note:

- Speeches must be original. Plagiarism or copying will lead to disqualification.
- Offensive remarks against any religion, government, sect, or prominent personalities will result in immediate disqualification.
- ❖ Participants must address the audience as "Mr. President" during their speech.
- The use of inappropriate language, disrespectful gestures, or any form of misconduct will lead to negative marking or disqualification.
- The decision of the judges will be final and cannot be challenged

Rules | Corporate Conundrum:

- Each team may have 2-3 members.
- Independent research is required using academic papers, financial reports, and real-world references.
- Use of financial models, audit techniques, IFRS, IAS, and forensic accounting methods is encouraged.
- The problem, implications, challenges, and solutions must be properly addressed.
- Plagiarism is strictly prohibited.
- Presentation material must be submitted one day before the final day for Al detection.
- Presentation time is limited to 8-10 minutes, with penalties for exceeding the limit.
- PowerPoint slides or equivalent visual aids are recommended.
- Formal business attire is mandatory.
- ❖ A 3–5 minute Q&A session will follow each presentation.
- ❖ Teams must justify their findings and recommendations Failure to answer key questions will result in point deductions.
- ❖ Presenting Al-generated content without critical analysis will lead to penalties or disqualification.

Case Study Brief:

All participating teams will receive, immediately after their participation is confirmed, a single intensive case study requiring deep financial analysis, critical thinking, and professional judgment. The case study will cover areas such as:

- Financial fraud detection & forensic auditing
- Corporate financial mismanagement & governance failures
- Economic downturns and global financial challenges
- Industry-specific financial challenges Accounting ethics and
- regulatory failures

Participation Fees: PKR 5,000 Per Participant

- Each participant is allowed to bring up to two (2) attendees free of charge.
- Registrations slots are limited to 22-30 participants only.
- Limited slot available: 7 English, 7 Urdu and 7 Humorous

Corporate Conundrum Contest:

Participation Fee: PKR 15,000/- Per Team

- Each team shall consist of minimum 2 and maximum 4 members
- Each team is allowed to bring up to two (2) attendees free of charge.
- Registrations slots are limited to 5 Teams only.
- Teams will be registered on first-come-first-served-basis.
